4.2 FTIP Update

John Asuncion, SCAG, reported the following:

- All 2017 FTIP Amendments had been approved except two 2017 FTIP Consistency Amendments #17-03 and 17-07.
- County project submittal for 2017 FTIP Amendment #17-08 was due to SCAG on April 4, 2017.

4.3 RTP Update

Daniel Tran, SCAG, reported the following:

- SCAG staff would presented Proposed Final 2016 RTP/SCS Amendment #1 to SCAG's Regional Council for adoption on April 6, 2017.
- Federal approval of the Amendment #1 was anticipated for June 2017.
- SCAG staff was working on 2016 RTP/SCS Amendment #2 and would seek approval from SCAG's Transportation Committee on April 6, 2017 to release Draft Amendment #2 for a 30-day public comment period. A public hearing was scheduled to be held at SCAG's downtown LA office on April 25, 2017 at 3:00 PM.
- Federal approval of the Amendment #2 was anticipated for August or September 2017.

4.4 EPA Update

Wienke Tax, EPA Region 9, reported the following:

- EPA and SCAQMD staff were still working together to resolve sanctions clock related to EPA's partial disapproval of 2012 South Coast Air Quality Management Plan/PM<sub>2.5</sub> State Implementation Plan (SIP).
- If underlying deficiencies not resolved in time, stationary offset sanction would begin in November 2017, followed by highways sanctions in May 2018.

Karina O'Connor, EPA Region 9, reported that EPA staff was still reviewing OCTA/SR-241 TCM substitution data and anticipated further progress by April TCWG meeting.

4.5 ARB Update

Dennis Wade, ARB, reported the following:

- ARB staff was also reviewing OCTA/SR-241 TCM substitution data alongside EPA staff.
- ARB approved Coachella Valley ozone SIP, South Coast ozone and PM<sub>2.5</sub> SIPs, and Ventura County ozone SIP on March 24, 2017. These SIPs would be submitted to EPA for review and approval within next few months.
