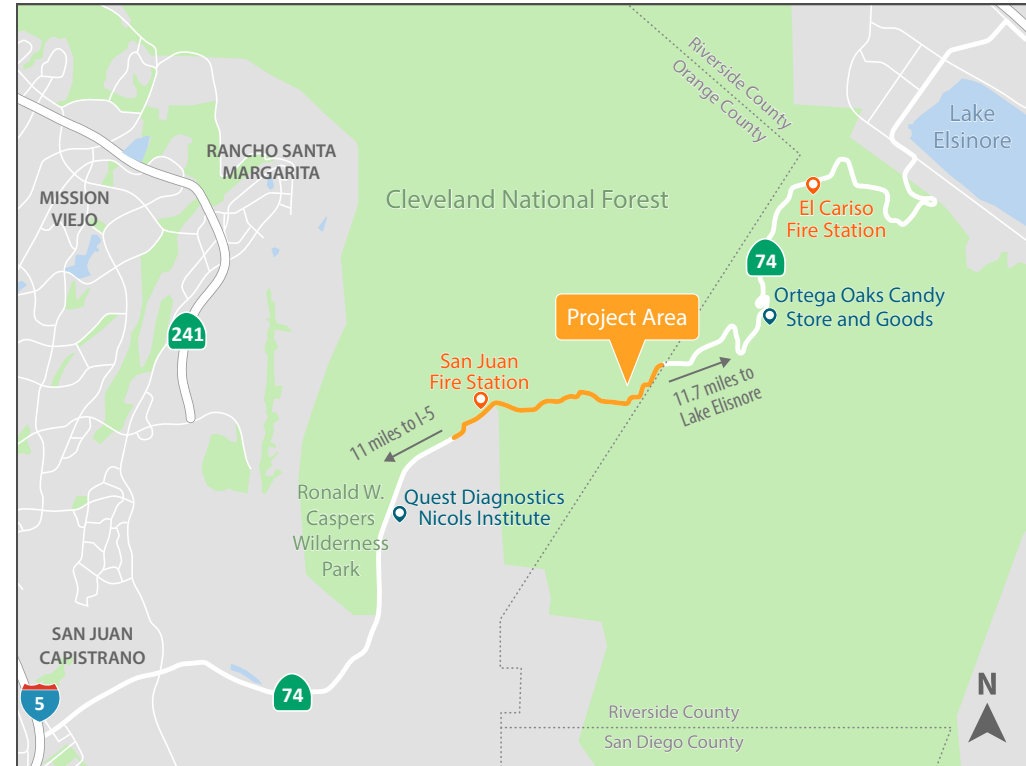
SR-74 Safety Improvement Project

What's Being Planned?

The California Department of Transportation (Caltrans) proposes to improve a segment of State Route 74 (SR-74), also known as Ortega Highway, in unincorporated Orange County. The project proposes to improve the segment of SR-74 just west of the San Juan Hot Springs Canyon to the Orange/Riverside County line. The project would resurface the existing roadway, add a continuous shoulder in both directions, enhance drainage, and provide superelevation and lighting improvements, as well as other safety improvements, within the project limits.

Why This Notice?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an Initial Study/Environmental Assessment (IS/EA). This notice is to tell you of the preparation of the proposed Mitigated Negative Declaration (MND) and IS/EA and of its availability for your review. A public hearing will be held to give you an opportunity to discuss the proposed work with Caltrans staff before the final design is selected.
