- Credit Report with **FICO score** that is not more than 30 days old
- Photo copy of driver's license or photo ID
- Photo copy of social security card or U. S. Passport
- An executed "Request for Copy of Personal Income Tax or Fiduciary Return"
- **IF SELF-EMPLOYED:** A copy of tax returns for the previous 2 years.

Pet Owners are required to submit the following:

- Pet Application listing all pets
- A Color Photo of each pet
- Pet Insurance
- Pet License
