

## Announcement of Public Information Meeting/Open House for the State Route 140 Ferguson Slide Permanent Restoration Project

### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans), as assigned by the Federal Highway Administration, is proposing to permanently restore and reopen the section of State Route 140 that was damaged by the Ferguson rockslide. Motorists are currently using a temporary bypass route to travel this section of State Route 140. Restoration of the original route would eliminate inconvenient detours and extended commute times to residences, businesses, and workers in the area. Restoration of the original route would also give travelers a direct route to Yosemite National Park and other destinations along State Route 140. Eight build alternatives and the no-build alternative are being considered.

### WHY THIS NOTICE?

Caltrans is in the process of preparing a draft Environmental Impact Report/Environmental Impact Statement based on comments received during the circulation of the Initial Study/Environmental Assessment. As part of this process, new alternatives are currently being analyzed. The Public Information Meeting/Open House will give you the opportunity to learn more about these alternatives and provide input.

### WHAT IS AVAILABLE?

Design alternatives and other displays explaining the project development process will be available for viewing. Caltrans staff specialists in engineering and environmental planning will be available to discuss your concerns and answer your questions. No formal presentation will be made. Please come by between the hours of 4:00 p.m. and 7:00 p.m.
