- ⁴ RSTP Exchange for FFY 06/07 was calculated on the Estimate vs Actual RSTP apportionment. Because the Actual apportionment was lower than the Estimate, the RSTP exchange from Plumas was higher than it should have been. The RSTP exchange for FFY 07/08 absorbed some of the negative balance.
- ⁵ MOU was entered into between Amador, Calaveras & Tuolumne-balances adjusted accordingly. (MOU spans five FFYs).
