November 2007 OA Delivery report projected base OA and \$50M OA payback amounts were revised to reflect an OA adjustment for six rurals receiving CMAQ and RSTP funds in 2008. Calculation formulas were corrected for CMAQ and RSTP apportionments for the rurals receiving CMAQ funds.

SRTS is the federally funded State Routes to School Program enacted with SAFETEA-LU.

- ¹ The projected base FFY 2008 OA is calculated based on 47 days actual OA per FRO's report dated November 5, 2007. This 47-day Local OA amount is then annualized to create an FFY 2008 OA Projection (projected base OA lowered by \$51 - variance in FFY 2007 final OA [see footnote 12 in September 30, 2007 Delivery report]).
- ² Balance of FFY 2007 OA -- This is the amount a Region must pay back if over delivered or the amount a Region will receive to "make whole" if under delivered based on the Amounts shown in parenthesis are amounts owed back and positive (non-parenthesis numbers) amounts are amounts owed to those

DLA OA Management Plan. DLA, as a whole, under delivers the OA in an FFY and this under delivered OA is "lost" to the State because of DLA under delivery -- Regions/Programs.

- ⁸ Rail information is included here for informational purposes. Beginning with the October 31, 2007 Delivery Report -- Rail Obligations/Deobligations and OA will no longer be included in Local Assistance Amounts. However, necessary to show Rail's information for continuity from FFY 2007 September 30, 2007 Delivery Report. Rail FFY 2008 carry-over and payback Obligations/Capital will participate in the FFY 2008 payback of \$50,000,000 to Local Assistance (see footnote 3). This does not impact Projected FFY 2008 OA for the Regions or Programs.

Based on FFY 2007 September 30, 2007 year-end reconciliation with FRO, this amount is an adjustment to OA that will be made in FFY 2008. The \$899,806 equals

the \$800,993.51 OA adjustment plus the \$98,812 carry-over OA (see September 30, 2007 Delivery report footnotes 11 and 12). These adjustments increase OA

to the Local's FFY 2008

Projected FFY 2008 Target OA includes OA adjustments to the "Total" as follows: 1) Decrease to Local's OA of \$51 for variance to FRO numbers for Local's FFY 2007 remaining OA (see September 30, 2007 Delivery report footnote 12); 2) Increase to Local's OA of \$800,993.51 for post FFY 2007 OA adjustments based on reconciliation with FRO (see September 30, 2007 Delivery report footnote 11); 3) Increase to Local's OA of \$98,812 for "carry-over" FFY 2007 OA (see September 30, 2007 Delivery report footnote 12); 4) Decrease to Local's OA of \$50 million of OA payback from Capital (reduces Local's OA).
