A Water Pollution Control Manager must be assigned to implement the SWPPP. The WPC Manager must comply with the Permit (Order No. 2009-0009-DWQ, NPDES No. CAS000002) qualifications for a QSP and QSD. The QSD must have the following qualifications:

1. Department approved storm water management training described in the Department's "Construction Storm Water and Water Pollution Control" web site
2. Registration or certification described in the Permit

This means you must have both the Caltrans 24 hour training and meet the requirements for a QSD.
