Each Task Order would be a minimum of eight (8) hours.
- Prevailing Wage Rates are required. Contractor must pay prevailing wage rates.
- Include wages, overhead, general administrative expenses, ALL APPLICABLE SALES TAXES, and profit in bid price.

\*Contractor will be reimbursed for the actual cost of these specified items in performance of this Agreement without additional allowance for markup.
