Dear Mr. Seaberg,

On Wednesday, June 18th, 2014, Ghilotti Construction Company bid the above referenced project. During a review of Granite Construction's (Granite) bid documents submitted subsequent to the bid opening, it was determined that Granite failed to properly submit the "Subcontractor List" form. Accordingly, Ghilotti Construction Company hereby formally protests an award of this contract to Granite. Their bid should be deemed nonresponsive.

The Dept. of Transportation should reject Granite's bid as nonresponsive because it failed to properly submitted the Subcontractor List form.

On the Subcontractor list form, Granite identified Apply-A-Line as performing the work for items 5, 6, 32, 106, 107 and 108 at greater than 100 percent. (Example A)

The Department has made a determination regarding this improper submittal previously when it found Coast Construction non-responsive for the identical reason. (Example B)

The Subcontractor List form states in part, "... Complete columns 1 and 4 and submit with the bid. Complete columns 2 and 3 and submit with the bid... Failure to provide complete information in columns 1 through 4 within the time specified will result in a nonresponsive bid."

As such, the Department must find Granite's bid nonresponsive.

Based on this information, Ghilotti Construction Company hereby protests an award of this contract to Granite.

Failure to provide complete information in columns 1 through 4 within the time specified will result in a non-responsive bid." When Coast submitted the percent of bid item subcontracted, as required in column 3, it listed more than 100 percent of the work for items 11, 24 and 26 would be subcontracted.

Based on the above, the Department finds your bid is non-responsive. The Department will proceed to award the contract to the lowest responsible bidder provided all requirements are met.
