After a review of the submittal for the DVBE/SB participation Truesdell Corporation has submitted Titan DVBE to prepare the WPCP for this proposal. Item 6 on form DES-OE-0102.2 states Titan DVBE will prepare the plan for the amount shown however, in review of their DES-OE-0102.8, Truesdell also stated that Global Environmental would be preparing the same item of work for the same unit price.

As requested and stated by the State Office, back-up materials should and will be submitted with each submittal or the bid would be considered non-responsive.
