

Please consider this letter as a protest of the bid submitted by Shasta Services, Inc., DBA Timberworks for contract 03-0F6904. The bid submitted by Timberworks is nonresponsive and must be rejected because they failed to comply with the instructions to bidder relating to DBE requirements; and expanded the scope of work for S.T. Rhoades Construction and Frank Medina Engineering. From their 24 hour Subcontracting Listing to their DBE commitment which is in violation of Subletting and Subcontracting Fair Practices Act of the Public Contract Code.

The DBE Commitment Form specifically states, "IMPORTANT: Identify all DBE firms being claimed for credit, regardless of tier. Names of First Tier DBE Subcontractors and their respective item(s) of work listed above must be consistent, where applicable, with the names and items of work in the "Subcontractor List" submitted with your bid. Copies of DBE quotes are required." Therefore, any discrepancy between the items of work listed for the subcontractors on the Subcontractor List and the items of work listed for the same subcontractors on the DBE Commitment form is grounds to find the bid nonresponsive.

Timberworks listed A.C. Dike to perform 100% of bid item 66 (Place Hot Mix Asphalt, Misc Areas) on the Subcontractor List, and then listed both S.T. Rhoades and A.C. Dike for item 66 on the DBE Commitment form. If A.C. Dike is already performing 100% of item 66, how can two firms now perform that item unless Timberworks post bid modified the items and percentages of their subcontractors, which is a violation of the subcontractor listing laws. In addition, Timberworks added bid item 61 (Minor Hot Mix Asphalt) to S.T. Rhoades scope of work on the DBE Commitment form, and not on the Subcontract List.

Timberworks also expanded Frank Medina Engineering's scope of work by adding bid item 96 (Vegetation Control, Minor Concrete). Vegetation Control, Minor Concrete does not fall under the descriptions that Timberworks listed for Frank Medina at bid time. The adding of these items to both S.T. Rhoades and Frank

Medina violated the subcontractor listing laws by giving Timberworks the opportunity to manipulate their subcontractors by negotiating post bid and adding bid items to their scopes. Caltrans has several times found this type of practice to be a violation of the subcontractor listing law and has found the bidder to be non-responsive. (see contract 03-4F3404)

Timberworks ambiguity in description of work, discrepancies between the DBE Commitment Form and the Subcontractor List, are grounds for Caltrans to determine Timberwork's bid to be nonresponsive.

Dear Mr. Stannard:

The Department of Transportation (Caltrans) received a bid from A. Teichert & Sons, Inc. dba Teichert Construction (Teichert) for contract 03-4F3404 on October 15, 2014. By this letter, Caltrans notifies Teichert that its bid is nonresponsive because the Disadvantaged Business Enterprise (DBE) form submitted is inconsistent with the Subcontractor List form in violation of the bidding instructions.

The DBE Commitment Form expressly states that "Names of the First Tier DBE Subcontractors and their respective item(s) of work listed must be consistent, where applicable, with the names and items of work in the Subcontractor List." Teichert listed the subcontractor ABSL on its DBE Commitment form to perform Bid Item 16 (Roadway Excavation), but failed to list ABSL on the Subcontractor List form. ABSL is listed for performing work in the amount of \$16,300 which, on a bid of \$3,161,385, meets the listing threshold of 1/2 of 1 percent or \$10,000.

Caltrans reviewed all of the documents submitted by Teichert, and based on the description of work provided in the quote submitted by ABSL, determined that ABSL provides the equipment, as well as the operator to perform the scope of work. In addition, the work being performed by ABSL requires a contractor's license. It is therefore, Caltrans' determination that ABSL is a subcontractor performing more than 1/2 of 1 percent of the work and not merely an equipment supplier and must be listed on the subcontractor list form.

Based on the above findings, Caltrans will proceed to award this contract to the lowest responsive and responsible bidder provided that all requirements have been met.
