

Overtime Rate: \$ 30.00 per hour additional (Over 8 Hours on Job Site) $30 \times 6 = 180$

Surcharges

Travel Rate: \$ 115.00 per hour (Portal-to-portal) $115 \times 24 = 2760$
Per Diem: \$ 110.00 per diem (Per Nightly Lodging if necessary) $110 \times 13 = 1430$
Weekend Hold: \$ 80.00 per hour with a 6 hour minimum (Per day lodging onsite during weekend)
Cancellation: \$ 95.00 per hour with a 6 hour minimum (Per scheduled day canceled)
Weekend Rate: \$ 15.00 per hour additional (Saturday, Sunday, and Holidays) (Negotiable)




