The Department of Transportation (Caltrans) received the attached letter dated March 19, 2014, from Condon-Johnson & Associates (Condon-Johnson) for contract 04-4S6204 in response to a nonresponsive bid finding on March 13, 2014.

As you are aware the bid was found nonresponsive due to an inconsistent Disadvantaged Business Enterprise (DBE) Commitment form and Subcontractor List form where Condon-Johnson failed to list ABSL as subcontractor on its Subcontractors List form.

Caltrans, in order to ensure fairness and maintain the integrity of the bidding process, must review and determine the validity of all bids received. Caltrans, in accordance with this business practice, did perform a review of all documents submitted by Condon-Johnson and determined that ABSL provides the equipment, as well as the operator to perform the scope of work. As such, ABSL is performing more than ½ of 1 percent of the work and Condon-Johnson is required to list ABSL on its Subcontractor List form.

Based on the above findings, Caltrans upholds its original finding of a nonresponsive bid and will proceed to award this contract to lowest responsive and responsible bidder.

Condon-Johnson & Associates, Inc. is in receipt of your letter dated March 17, 2014 which notifies Condon-Johnson that its bid is nonresponsive. The reason provided for the bid being deemed nonresponsive is based on non-compliance with a requirement of the DBE commitment form which states, "Names of the first tier DBE subcontractors and their respective item(s) of work listed above must consistent, where applicable, with the names and items of work in the Subcontractor List". We do not believe we have violated the requirement of the DBE Commitment Form because while ABSL is a DBE they did not bid the work as a Subcontractor. Per the requirement quoted, the DBE form must be consistent with the Subcontractor list "where applicable" (ie the DBE must be a Subcontractor).

ABSL was not listed on the Subcontractor Listing form because ABSL bid the project on an operated equipment rental basis. They did not bid the project by Bid Item, as a Lump Sum or per plans and specifications. Attached, please find ABSL quotation which clearly demonstrates they bid the project with a menu of operated equipment rental rates.

Caltrans also considers equipment rental with or without an operator as not being a subcontractor. This is indicated in the Standard Specifications Section 5-1.13 "Subcontracting" where Caltrans states "perform work equaling at least 30% of the value of the original total bid with your employees and with equipment you own or rent, with or without operators".

In addition, Caltrans has awarded work to a General Contractor in the past which was bid exactly the way Condon-Johnson listed the work on this bid. On Contract Number: 04-3E6304 bid 4/03/2013 RGW listed ABSL on the DBE commitment form but failed to list them on the Subcontractor List and was subsequently awarded the work.

Based on the above we request that the nonresponsive finding be withdrawn.







The Department of Transportation (Caltrans) received the attached letter dated March 19, 2014, from Condon-Johnson & Associates (Condon-Johnson) for contract 04-4S6204 in response to a nonresponsive bid finding on March 13, 2014.

As you are aware the bid was found nonresponsive due to an inconsistent Disadvantaged Business Enterprise (DBE) Commitment form and Subcontractor List form where Condon-Johnson failed to list ABSL as subcontractor on its Subcontractors List form.

Caltrans, in order to ensure fairness and maintain the integrity of the bidding process, must review and determine the validity of all bids received. Caltrans, in accordance with this business practice, did perform a review of all documents submitted by Condon-Johnson and determined that ABSL provides the equipment, as well as the operator to perform the scope of work. As such, ABSL is performing more than ½ of 1 percent of the work and Condon-Johnson is required to list ABSL on its Subcontractor List form.

Based on the above findings, Caltrans upholds its original finding of a nonresponsive bid and will proceed to award this contract to lowest responsive and responsible bidder.
