Office Engineer:

This is written in response to your letter, dated May 27, 2014, stating that our bid for Contract No. 05-1F4804 is non-responsive due to the fact that our Subcontracting percentages for Bid Items 3 and 4 were listed as "+/-".

Please be advised that the inclusion of a "+/-" is an inadvertent clerical error that should be waived and forgiven. If the characters "+/-" are not allowed, then Electronic Bid Documents should not have allowed us to input these characters in with a bid percentage. In any case, it is simply a case of an inadvertent and inconsequential clerical error and it should be dismissed.

The dollar amount shown for KRC Safety for Bid Item 3, Traffic Control, on our DBE Commitment Form, \$14,265.00, represents 45.8681% (+/-46%) of our budgeted cost of \$31,100 for Traffic Control, not including Overhead, Profit and Mobilization Costs.

The dollar amount shown for KRC Safety for Bid Item 4, Portable Changeable Message Sign, on our DBE Commitment Form, \$1,400.00, represents 50.3597% (+/-50%) of our budgeted cost of \$2,780.00 for Portable Changeable Message Signs, not including Overhead, Profit and Mobilization Costs.

This manner of calculating "Percentages of Bid Items Subcontracted" is consistent with all of our other items of work. As an example Bid Item 2, Construction Area Signs, we listed KRC Safety for 100% of the item and their price to us was \$2,500.00, per KRC Safety's quote and our DBE Commitment Form. However, our Bid Item Price is \$5,000.00. Accordingly, the only error, if any, is the inadvertent inclusion of a "+/-" symbol.

Also, please note that in accordance with the KRC Safety Co., Inc., quote dated 5-14-2014, copy attached, the amount to be paid to KRC Safety for Bid Items 3 and 4 are subject to change based on the actual project duration. For these items, all of KRC Safety's Equipment (Impact Attenuator Vehicle, Flashing Arrow Signs, Portable Light Tower and Portable Changeable Message Sign) are quoted by the day, week and month only, are not firm fixed Lump Sum costs

for the project. The prices quoted by KRC Safety for various Lane Closures options are also based on a "per 8 hour shift" and are subject to change based on any overtime incurred in the performance of the work. The amounts shown in our Subcontractor List are based on our Project Bid Estimate and Bid Duration. If the actual project duration is different than our original bid duration, then the final amount to be paid to KRC Safety for Bid Items 3, Traffic Control, and 4, Portable Changeable Message Signs, will change.




