Dear Mr. Walker:

The Department of Transportation (Caltrans) received a bid from Griffith Company (Griffith) for contract 06-0Q8104 on March 26, 2014. By this letter, Caltrans notifies Griffith that its bid is nonresponsive because it failed to properly complete the Subcontractor List form.

Caltrans 2010 revised Standard Specifications, Section 2-1.33C states in part, "...*The Subcontractor List must show the name, address, and work portions to be performed by each subcontractor listed. Show work portions by bid item number, description, and percentage of each bid item subcontracted*". On the Subcontractors List form, Central Striping to perform work described as striping. However, in column 3, Percentage of Bid Items Subcontracted Griffith listed percentages that exceed 100% of the amount for the work to be performed.


Based on the above, Caltrans will proceed to award the contract to the lowest responsible bidder, provided that all requirements are met.
