1. Required training specified in the LCP can be conducted (under the direction of a CIH) at contractor location. The training can be conducted for a lump sum of \$1,950.00 per event.
2. Required personal air monitoring specified in the LCP can be conducted (under the direction of a CIH) for \$1,950.00 per shift and per location. Up to four (4) project personnel will be monitored for the effort. Monitoring includes all labor, travel, equipment, materials, supplies, reporting and lab costs. A mobilization fee of \$600.00 will be charged for the first event and any non-consecutive monitoring events that follow. The Prime can assume one (1) event of monitoring will be required for the project.
3. Job Site Management assumes a project duration of 50 days (field work), or 10 weeks of on-site field work.


