Mrs. Sewell:

Beador Construction Company Inc. hereby protests the finding of our above mention contract bid proposal non-responsive. Presumably, the Department found our bid non-responsive due to the bid bond not being at the Departments office prior to bid time. The attached correspondence and delivery receipts prove otherwise. The Department received our bid bond on bid day (June 1st) at 9:49 AM (See exhibit 1 & 1A attached). L. Parra signed for the overnight package (signature attached). The Department then apparently put my package (containing the bid bond) in the outgoing GSO and it was sent out that day and redelivered to your office the next day and signed again by L. Parra at 9:44 AM. (Exhibit 2 & 2A). The Department can verify it was the same package as the tracking number is the same for both deliveries (532090800). You cannot have the same tracking number for two separate deliveries thus verifying it was the same package. An explanation email is also attached from GSO explain what had happened and verifying the Department's error (Exhibit 3).

We request the Department immediately reinstate our bid proposal due to the above mentioned Departments error.




