Dear Mr. Chumo:

The Department of Transportation (Caltrans) received the attached letter dated November 3, 2014, from Highland Construction, Inc. (Highland), protesting Chumo Construction, Inc.'s (Chumo) bid. The protest alleges that Chumo listed Flatiron Electrical Group, Inc. (Flatiron) for 100% of Bid Item 7 on the Subcontractor List form; however upon further review Highland found that Chumo's Bid Item 7 does not reflect the same price as Flatiron represented in their actual proposal, and that the Subcontractor List form does not represent the true percentage of work being subcontracted to Flatiron.

Highland also alleges that Chumo's Subcontractor List form misrepresents the work that is to be performed by Condon-Johnson & Associates, Inc. (Condon-Johnson) for Bid Item 43. In particular, Chumo listed Condon-Johnson for 100% of Bid Item 43, Clean and Paint Steel, and Condon-Johnson excluded the application of a final paint coating, in the field, after the steel soldier piles are installed in their work and proposal.

Please provide your response to Highland's protest no later than November 11, 2014.

We hereby protest the award of the above-mentioned contract to the 1st apparent low bidder Chumo Construction, Inc. (Chumo) for the following:

Failure to Adequately List True Percentage of Subcontracted Work for Bid Item #7:

Upon review of Chumo's bidder documents posted at Caltrans' website, we found that Chumo listed Flatiron Electrical Group, Inc. (Flatiron) for 100 percent of Bid Item #7 (Exhibit 1). A further review of Chumo's Bid Item #7, shows that the price submitted by Chumo does not reflect the same price that Flatiron represented in their actual proposal. More importantly, the Subcontractor Listing does not reflect the true percentage of work being subcontracted to Flatiron.

Chumo's submitted price for Bid Item #7 is \$360,563.00 (Exhibit 2). However, Flatiron's proposal for Bid Item #7 exclusively is \$355,653.00 (Exhibit 3 & 4), which is below Chumo's bid price and represents less than 100% had Flatiron's proposal only included this dollar amount. However, Chumo completely excluded Flatiron's costs for "mobilization" (Bid Item #52), to perform the work for Bid Item #7, from its bid and Subcontractor Listing. As listed in Flatiron's proposal, their mobilization costs for performing the work for Bid Item #7 is \$20,000.00, which brings the total cost of Flatiron's work to \$375,653.00.

The prime contractor has two choices with regards to mobilization for the subcontractor's work for specific bid items. The prime can either incorporate those mobilization costs for the subcontractor's item work into each of the particular bid items to which they relate and not list the subcontractor for the specific bid item of mobilization. Or, the prime may separate the subcontractor's costs of mobilization and incorporate it into the specific mobilization bid item.

However, in the latter case, the prime contractor would have to accurately list the subcontractor for the related mobilization bid item in the prime's Subcontractor Listing, providing the subcontracted amount is in excess of the Subletting Act threshold of $\frac{1}{2}$ of 1 percent or \$10,000.00. The prime contractor would also have to accurately record the percentage of work related to the subcontracted mobilization bid item. In Chumo's case, neither the true percentage of work nor the true bid items numbers, for which the work is subcontracted, are reflected accurately in Chumo's submitted Subcontractor Listing. Further, Chumo's bid price for Item #7 does not correlate with Flatiron's subcontractor quote.

On October 29, 2014, we contacted Flatiron's estimator, Mike Cuellar, to inquire if Flatiron reduced their costs to Chumo at any time before or after bid opening. Flatiron verified that they did not reduce their costs for either of the two bid items, to any prime contractor, prior to or post bid opening. We also confirmed that Flatiron did not have any communication with Chumo with regards to the total amount that Chumo listed Flatiron. The true cost of Flatiron's subcontracted work is \$375,653.00.

As Caltrans is aware, California courts have held that a mistake with regards to the percentage of work to be completed by a subcontractor is a mistake which provides the public entity no choice but to reject the bid. Please review, Valley Crest Landscape, Inc. v. City Council of the City of Davis (1996) 41 Cal.App 4th 1432.

Caltrans has always applied a strict standard with the information that is required in the Subcontractor Listing. Caltrans has upheld numerous nonresponsive finding for irregularities, mistakes, omissions, changes, etc. that are found in the Subcontractor Listing. Please see Caltrans Contract #02-0E3604 and #08-0P2804 (Exhibit 5 & 6), in which Caltrans held the bidder nonresponsive within this last month for similar irregularities in the Subcontractor Listing.

Failure to Adequately List True Percentage of Subcontracted Work for Bid Item #43:

Chumo's Subcontractor Listing also misrepresents the work that is to be performed by Condon-Johnson for Bid Item #43. In this case, Chumo lists Condon-Johnson for 100 percent of Bid Item #43, which is Clean & Paint Steel (Exhibit 1). Chumo's total price for Bid Item #43 is \$11,250.00 (Exhibit 7). Bid Item #43 requires the contractor to clean and paint the steel soldier piles (Bid Item #s 34 & 35 respectively). This work consists of applying a zinc undercoating from a SSPC Certified Enclosed Shop, for which Chumo listed Condon-Johnson. The misrepresentation occurs because the work in Bid Item #43 also consists of applying a final paint coating, in the field, after the steel soldier piles are installed, which Condon-Johnson excluded from their work and proposal (Exhibit 8).

Condon-Johnson's proposed price for the enclosed shop portion of Bid Item #43 is \$11,250.00, which is also Chumo's total bid price for the said item. Meaning, Chumo did not represent the costs for the field painting work as required for the said bid item, nor is Condon-Johnson performing 100 percent of the work described for Bid Item #43. Therefore, the percentage of work in Chumo's Subcontractor Listing is inaccurate.

Lastly, please refer to Section 59-2.01C(2) of the contract's Special Revision, which revised Caltrans' 2010 Standard Specification (Exhibit 9). In the said Section, the contractor is required to submit proof of an AISC420-10/SSPC-QP3 certification for Bid Item #43. A search of both the American Institute of Steel Contractors (AISC) and the Society of Protective Coatings (SSPC) databases indicate that Condon-Johnson does not have the required certification to even perform the work for which Chumo listed them to complete in its entirety (Exhibits 10, 11 & 12). In fact, Chumo submitted a SSPC-QP3 certification from Techno West, Inc., with its DBF information, which stands to reason that Techno West, Inc. may be the actual contractor performing the work for the enclosed shop portion of Bid Item #43. Either way, Chumo's Subcontractor's Listing percentages do not accurately reflect the actual work being subcontracted thereby rendering Chumo's Subcontractor Listing noncompliant with the Subletting Act and/or Caltrans' Subcontractor Listing requirement.

Due to the aforementioned, Caltrans has no option, but to reject Chumo's bid and find Chumo nonresponsive for failure to accurately represent the true percentages of subcontracted work in their submitted bidder proposal and Subcontractor Listing.

We hereby request that Caltrans proceed with award the the next apperent lowest responsive bidder, HighLand Consttuciton, Inc.



The Department of Transportation (Caltrans) received a bid submitted by Tricon Construction, Inc. dba Tricon Aquatics (Tricon) for Contract 02-0E3604 on September 17, 2014. By this letter, Caltrans notifies Tricon that its bid is nonresponsive.

Caltrans 2010 revised Standard Specifications, Section 2-1.33C states in part, "...The Subcontractor List must show the name, address, and work portions to be performed by each subcontractor listed. Show work portions by bid item number, description, and percentage of each bid item subcontracted". On the Subcontractors List form under Percent of Bid Items Subcontracted, Tricon listed the percentages for all bid items, with the exception of bid item 78, as a percentage of the total contract bid, rather than the percent of work to be performed. As a result, these percentages did not adequately represent an equivalent value/portion of work to be subcontracted.

Based on the above, Caltrans will proceed to award the contract to the lowest responsible bidder, provided that all requirements are met.

Your attention is directed to Section 3-1.04 of the 2010 Standard Specifications. Caltrans is not obligated to offer an extension of the award period for a nonresponsive bid. Should you wish to extend your bid while resolving a nonresponsive finding, you must send your request to the Office Engineer no later than 4:00 p.m., two business days prior to the expiration of your bid.



Dear Mr. Chumo:

The Department of Transportation (Caltrans) received the attached letter dated November 3, 2014, from Highland Construction, Inc. (Highland), protesting Chumo Construction, Inc.'s (Chumo) bid. The protest alleges that Chumo listed Flatiron Electrical Group, Inc. (Flatiron) for 100% of Bid Item 7 on the Subcontractor List form; however upon further review Highland found that Chumo's Bid Item 7 does not reflect the same price as Flatiron represented in their actual proposal, and that the Subcontractor List form does not represent the true percentage of work being subcontracted to Flatiron.

Highland also alleges that Chumo's Subcontractor List form misrepresents the work that is to be performed by Condon-Johnson & Associates, Inc. (Condon-Johnson) for Bid Item 43. In particular, Chumo listed Condon-Johnson for 100% of Bid Item 43, Clean and Paint Steel, and Condon-Johnson excluded the application of a final paint coating, in the field, after the steel soldier piles are installed in their work and proposal.

Please provide your response to Highland's protest no later than November 11, 2014.
