

USS CAL BUILDERS INC. ("USS") submitted a bid in the amount of \$64,774,889.35 for the above referenced project on August 27<sup>th</sup>, 2015 Project No. 08-3555V4 (the "Project"). Please be advised that this written request is being submitted on August 31, 2015 within five (5) working days of the bid opening excluding Saturday and Sunday.

USS is requesting that it be allowed to withdraw its bid due to the fact that a clerical error was made in writing down the correct figure for the line item noted below.

In writing down the total amount of each line item, my assistant mistakenly inputted inaccurate information. Line item number 314 (Mobilization) should be \$6,900,000.00 instead of the \$1,900,000.00 as indicated in the bid submittal. This clerical mistake resulted in the bid being materially different than what it was intended to be.


As you can see from the above:
