This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN SANTA CLARA COUNTY ON ROUTE 25 FROM SAN BENITO COUNTY LINE TO ROUTE 101/25 SEPARATION AND ON ROUTE 156 FROM SAN BENITO COUNTY LINE TO ROUTE 152.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Wednesday, April 7, 2010.

This addendum is being issued to revise the Project Plans, the Notice to Bidders and Special Provisions, and the Bid book

Project Plan Sheets 42 and 44 are revised. Copies of the revised sheets are attached for substitution for the like-numbered sheets.

Project Plan Sheets 43 was omitted. A copy of the omitted sheet is attached for addition to the project plans.

In the Amendments to the Standard Specifications Dated May 2006, Section 2-1.12, "BID DOCUMENT COMPLETION," subsection 2-1.12A, "General," is revised as follows:

"2-1.12A General

Complete forms in the Bid book.

On the Subcontractor List you may either submit each subcontracted bid item number and corresponding percentage with your bid or fax this information to (916) 227-6282 within 24 hours after bid opening. If you fail to submit this information within the time specified, your bid is nonresponsive.

Except for the bid item number and the percentage of each item subcontracted, do not fax submittals."

In the Bid book, the "SUBCONTRACTOR LIST," form is revised as attached.

To Bid book holders:

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the Notice to Bidders section of the Notice to Bidders and Special Provisions.

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the Bid book.

Submit bids in the Bid book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.

Inform subcontractors and suppliers as necessary.
