Dear Contractor:

This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN SONOMA COUNTY NEAR GEYSERVILLE AT THE RUSSIAN RIVER BRIDGE.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Wednesday, March 10, 2010, instead of the original date of Wednesday, February 24, 2010.

This addendum is being issued to set a new bid opening date as shown herein and revise the Notice to Bidders and Special Provisions, and the Bid book.

In the Notice to Bidders and Special Provisions, in the "NOTICE TO BIDDERS," the eleventh and twelfth paragraphs are revised as follows:

"Complete the work, including plant establishment work, within 836 working days.

"The estimated cost of the project is \$710,000."

In the Special Provisions, Section 4, "BEGINNING OF WORK, TIME OF COMPLETION, AND LIQUIDATED DAMAGES " the last paragraph is revised as follows:

"Complete the work, including plant establishment work, within 836 working days."

In the Special Provisions, Section 10-2.04, "HIGHWAY PLANTING," subsection "PLANT ESTABLISHMENT WORK," the first paragraph is revised as follows:

"The plant establishment period shall be Type 1 and shall be 750 working days."

In the Amendments to the Standard Specifications Dated May 2006, Section 2-1.12, "BID DOCUMENT COMPLETION," subsection 2-1.12A, "General," is revised as follows:

**"2-1.12A General**

Complete forms in the Bid book.

On the Subcontractor List you may either submit each subcontracted bid item number and corresponding percentage with your bid or fax this information to (916) 227-6282 within 24 hours after bid opening. If you fail to submit this information within the time specified, your bid is nonresponsive.

Except for the bid item number and the percentage of each item subcontracted, do not fax submittals."

In the Bid book, in the "SUBCONTRACTORS LIST," form is revised as attached.

To Bid book holders:

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the Notice to Bidders section of the Notice to Bidders and Special Provisions.

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the Bid book.

Submit bids in the Bid book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.

Inform subcontractors and suppliers as necessary.
