This addendum is being issued to revise the project plans, the *Notice to Bidders and Special Provisions* and the Federal Minimum Wages with Modification Number 2 dated 1/24/2013.

Project plan sheets 1 to 11 and 13 to 17 are replaced and attached for substitution for the like-numbered sheets.

Project plan sheet 12 is deleted.

In the Special Provisions, Section 39-1.03B the last paragraph is replaced as follows:

"Determine the OBC for RHMA-G at 4 percent air voids under California Test 367. The OBC must be greater than or equal to 7.5 percent based on the total weight of mix."
