Dear Contractor:

This addendum is being issued to the contract for construction on State highway in SAN LUIS OBISPO AND MONTEREY COUNTIES NEAR PASO ROBLES FROM SAN MARCOS ROAD TO 1.0 km SOUTH OF JOLON ROAD UNDERCROSSING.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on August 28, 2001.

This addendum is being issued to revise the Notice to Contractors and Special Provisions, and the Federal Minimum Wages with Modification Number 8 dated 8-10-01. A copy of the modified wage rates are available for the contractor's use on the Internet Site:

In the Special Provisions, Section 5-1.14, "PAYMENTS," the following paragraphs are added after the first paragraph:

"For the purpose of making partial payments pursuant to Section 9-1.06, "Partial Payments," of the Standard Specifications, the amount set forth for the contract items of work hereinafter listed shall be deemed to be the maximum value of the contract item of work which will be recognized for progress payment purposes:

A. Clearing and Grubbing \$2,000

After acceptance of the contract pursuant to the provisions in Section 7-1.17, "Acceptance of Contract," of the Standard Specifications, the amount, if any, payable for a contract item of work in excess of the maximum value for progress payment purposes hereinabove listed for the item, will be included for payment in the first estimate made after acceptance of the contract."

To Proposal and Contract book holders:

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the proposal.

Submit bids in the Proposal and Contract book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.

Inform subcontractors and suppliers as necessary.
