This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN KERN COUNTY IN AND NEAR BUTTONWILLOW FROM ROUTE 5/99 SEPARATION TO 0.1 MILE SOUTH OF KERN RIVER UTILITY ROAD OVERCROSSING AND FROM 0.6 MILE NORTH OF ROUTE 5/58 SEPARATION TO LERDO AVENUE OVERCROSSING.

This addendum is being issued to revise the Notice to Bidders and Special Provisions.

In the Special Provisions, Section 10-1.21, "BONDED WEARING COURSE-GAP GRADED," subsection "MATERIALS," sub subsection "Aggregate," the first paragraph is revised as follows:

"The aggregate for HMA in bonded wearing course must comply with the 3/8-inch aggregate gradation grading specified in the aggregate gradation tables."

In the Special Provisions, Section 10-1.21, "BONDED WEARING COURSE-GAP GRADED," subsection "MATERIALS," sub subsection "Aggregate," the "Aggregate Gradation" tables for 1/2-inch HMA and No.4 HMA are deleted.
