Dear Contractor:

This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN KERN COUNTY NEAR LOST HILLS FROM SAN LUIS OBISPO COUNTY LINE TO KECKS ROAD AND FROM 1.2 MILES WEST OF ROUTE 33 TO 0.5 MILE WEST OF BROWN MATERIAL ROAD.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Tuesday, April 23, 2013.

This addendum is being issued to revise the Notice to Bidders and Special Provisions.

In the Special Provisions, Section 39-1.02E, the first paragraph is revised as follows:

"Aggregate for RHMA-G must comply with the 3/8 inch RBWC-G gradation, as specified in Section 39-1.25B(4)."

In the Special Provisions, Section 39-1.25C(2), the following paragraph is added after the first paragraph:

"The 3/8-inch, RBWC-G and RHMA-G must comply the same requirements for VMA and stability as the RHMA-G 1/2" and 3/4" gradings, as specified in Section 39-1.03B of the Standard Specifications."

To Bid book holders:

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the Notice to Bidders section of the Notice to Bidders and Special Provisions.

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the Bid book.

Submit bids in the Bid book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.

Inform subcontractors and suppliers as necessary.
