Dear Contractor:

This addendum is being issued to the contract for construction on State highway in LOS ANGELES COUNTY IN LOS ANGELES AT SEPULVEDA BOULEVARD.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on November 8, 2007, instead of the original date of September 20, 2007.

This addendum is being issued to set a new bid opening date as shown herein and revise the Notice to Contractors and Special Provisions.

In Special Provisions, add Section 10-1.11, "BLANK".

In Special Provisions, Section 10-1.33, "CRASH CUSHION (ADIEM)," the fourth paragraph is revised as follows:

"The price quoted by the manufacturer for ADIEM-350, FOB Centerville, Utah is \$12,900, not including sales tax."

In Special Provisions, Section 10-1.33, "CRASH CUSHION (ADIEM)," the fifth paragraph is revised as follows:

"The above price will be firm for orders placed on or before January 15, 2008, provided delivery is accepted within 90 days after the order is placed."

To Proposal and Contract book holders:

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the NOTICE TO CONTRACTORS section of the Notice to Contractors and Special Provisions.

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the proposal.
