In the Special Provisions, Section 5-1.005, "CONTRACT BONDS," is revised as follows:

"Attention is directed to Section 3-1.02, "Contract Bonds," of the Standard Specifications and these special provisions.

The payment bond shall be in a sum not less than one hundred percent of the total amount payable by the terms of the contract."

In the Special Provisions, Section 10-1.10, "MAINTAINING TRAFFIC," Chart No. 2 is revised as attached.

To Proposal and Contract book holders:

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the proposal.

Submit bids in the Proposal and Contract book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.
