Dear Contractor:

This addendum is being issued to the contract for construction on State highway in RIVERSIDE COUNTY IN CORONA FROM 0.5 KM SOUTH OF MAGNOLIA AVENUE OVERCROSSING TO 0.6 KM NORTH OF MAGNOLIA AVENUE OVERCROSSING.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on August 23, 2007.

This addendum is being issued to revise the Project Plans, the Notice to Contractors and Special Provisions, and the Proposal and Contract.

Project Plan Sheet 160 is revised. A half-sized copy of the revised sheet is attached for substitution for the like-numbered sheet.

In the Special Provisions, Section 3, "AWARD AND EXECUTION OF CONTRACT," the third paragraph is revised as follows:

"The award of the contract, if it be awarded, will be to the lowest responsible bidder whose proposal complies with all the requirements prescribed. This period will be subject to extension for such further period as may be agreed upon in writing between the Department and the bidder concerned. The contract will not be awarded until the 2007/2008 fiscal year Budget Act becomes law."

In the Proposal and Contract, the Engineer's Estimate Item 125 is revised as attached.

To Proposal and Contract book holders:

Replace page 9 of the Engineer's Estimate in the Proposal with the attached revised page 9 of the Engineer's Estimate. The revised Engineer's Estimate is to be used in the bid.

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the NOTICE TO CONTRACTORS section of the Notice to Contractors and Special Provisions.

Indicate receipt of this addendum by filling in the number of this addendum in the space provided on the signature page of the proposal.

Submit bids in the Proposal and Contract book you now possess. Holders who have already mailed their book will be contacted to arrange for the return of their book.

Inform subcontractors and suppliers as necessary.
