This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN CALAVERAS AND AMADOR COUNTIES AT AND NEAR MOKELUMNE HILL FROM 0.3 MILE WEST OF PALOMA ROAD TO ROUTE 88.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

This addendum is being issued to revise the *Notice to Bidders and Special Provisions* and the Federal Minimum Wages with Modification Number 3 dated 1/31/2014.

In the *Notice to Bidders*, the eleventh paragraph is replaced as follows:

"Complete the work within 55 working days."

In the *Special Provisions*, Section 12-4.02A, the fifth paragraph is replaced as follows:

"The maximum length of a single stationary one-way reversing traffic-control lane closure is 1.5 miles between flaggers."
