This addendum is being issued to revise the *Notice to Bidders and Special Provisions*.

In the *Notice to Bidders and Special Provisions*, in the "STANDARD PLANS LIST," the following Standard Plans are added as follows:

"RSP A77L1, RSP A77M1, RSP A77N1, RSP A77N3, RSP A77N4, RSP A77Q1, RSP A77R3, RSP A77U1, RSP A77U2, RSP A77U4, RSP A77U5, RSP A87B, RSP H1, RSP H2, H51, RSP T9, RSP T11, RSP T14, RSP ES-4A, RSP ES-4C, and RSP ES-8A."

In the *Notice to Bidders and Special Provisions*, in the "STANDARD PLANS LIST," the following Standard Plans are deleted as follows:

"RSP A24A, RSA A24E, and RSP T17."

In the *Special Provisions*, Section 8-1.04F, the fifth paragraph is replaced as follows:

"If you obtain authorization to start job site activities for the date you requested, start job site activities on the requested date. If you fail to submit a request for authorization to start job site activities as specified or if the request is not authorized, start job site activities within 15 days after receiving notice of Contract approval. Start work before June 1, 2015."
