Re: Request for fencing and access gates under Mormon Slough Bridge

Dear Mr. Wong:

Board staff has reviewed your submitted request to place a fencing and access gates under the Mormon Slough bridge located at Lincoln Street in downtown Stockton. The scope of work consists of placing approximately 7,400 feet of wrought iron fence and thirteen access gates. The proposed fencing will prohibit pedestrians and unauthorized vehicles from accessing the area under the freeway bridges.

The Board has determined that the proposed work is a minor alteration within an adopted plan of flood control that would not be injurious to the adopted plan of flood control. Therefore, per Title 23 California Code of Regulations (CCR), Article 3, Section 6 (e), an encroachment permit will not be required for the proposed work. All work must be performed consistent with the plans attached (Attachment A).

Please be advised that additional authorizations may be required from other federal, State, and local agencies.

Dear Ms. Gill:

This letter requests your department approval to install approximately 7400 feet of wrought iron fence and thirteen access gates at the area under Mormon Slough Bridge (Bridge No 29-0238), at Lincoln Street, and alongside the West Route 4 to North Route 5 Connector (on ramp) (Bridge No 29-0236) in downtown Stockton.

There is a need to keep pedestrians from entering into the State's right of way and endangering the safety of the traveling public and themselves. The impact of homelessness present a substantial operational challenge for the Caltrans Maintenance crews who continue to report issues with homeless encampments and individuals on the State right-of-way. In San Joaquin County, homeless individuals and their encampments are raising a number of concerns for Caltrans as they move within the State right-of-way under the SR-4 structures. Homeless people are camping under the Mormon Slough Bridge and Lincoln Street and along the side of the westbound SR-4 to northbound SR-5 connector on ramp in downtown Stockton.

Caltrans' concerns include the safety of motorists, maintenance crews, and the homeless individuals themselves as they cross the freeways to gain access to these areas. Damage to the structures, land and landscaping, generating debris, and unsanitary conditions, including an accumulation of hazardous waste is a continuous problem. The excess amount of trash requires continuous clean up by Caltrans' maintenance crews and is costly to remove.






STATE PROPERTY PLAQUE - SR8 (CA)


FURNISH AND INSTALL SIGN DETAIL




