This addendum is being issued to revise the Notice to Bidders and Special Provisions, and the Federal Minimum Wages with Modification Number 2 dated 04/02/10.

In the Special Provisions, Section 5-1.09, "SUPPLEMENTAL PROJECT INFORMATION," is deleted.

In the Special Provisions, Section 10-1.20, "HOT MIX ASPHALT," subsection "AGGREGATE," the first paragraph is revised as follows:

"The aggregate for HMA Type A must comply with ½-inch grading."
