As a valued member of the Caltrans team, you make it possible for the Department to provide a safe, sustainable, integrated, and efficient transportation system to enhance California's economy and livability. Caltrans is a performance-driven, transparent, and accountable organization that values its people, resources and partners, and meets new challenges through leadership, innovation and teamwork.

**GENERAL STATEMENT:**

Incumbent works with and assists in supervising the work of a crew engaged in maintenance, construction work, or snow removal on highways and highway structures. The incumbent may operate and/or service highway maintenance, landscape or construction equipment described under Levels of Equipment for Caltrans Maintenance Worker, Caltrans Equipment Operator I, and Caltrans Equipment Operator II. Incumbent may learn to operate other equipment. Employee is required to maintain a Class "A" driver's license with tank vehicle endorsement.

**TYPICAL DUTIES:**

50%	E	Operate and service highway maintenance and snow/ice removal equipment identified as Levels of Equipment for Caltrans Equipment Operator II, Caltrans Equipment Operator I, and Caltrans Maintenance Worker. Properly operate 2-way radios. Use products that could be hazardous or dangerous. Perform heavy labor associated with highway structures, cleaning ditches, culvert openings, erosion control, vegetation control, planting and establishment, installing storm water protection measures, litter pickup. .
30%	E	Operate manual/power hand tools. Common hand tools to be used could be but are not limited to shovels, rakes, pitchforks, brooms, post-drivers and pullers, pruning sheers, picks, digging bars and wrenches, chainsaws, weed eaters, hay blowers and hydro seeders, jack-hammers, circular saws, power drills, power grinders. Move a variety of heavy objects. Perform custodial work. Perform litter and dead animal removal and disposal. Perform snow removal and ice control tasks such as truck, grader, or rotary plowing, snow stake installation, repair, and removal, and man chain control operations. Perform brush and small tree removal and disposal.  Perform Custodial work duties including but not limited to sweeping, emptying trash, cleaning restroom facilities and replenishing supplies  Perform brush and tree removal and disposal.  Perform Drainage maintenance.  Perform litter and dead animal removal and disposal.  Provides training on equipment.
10%	M	Attend all required training programs. Operation of "pilot car" and flagging duties, and other traffic control duties such as setting up lane closures on two-lane and multi-lane highways, set up cones, and operate shadow truck. Provides training on equipment. Perform minor repairs to maintenance stations and highway facilities.

## SUPERVISION OR GUIDANCE EXERCISED OVER OTHERS

Normally this position does not supervise, however, the incumbent may be placed in charge or called upon to act as leadperson for a short duration

## KNOWLEDGE, ABILITIES, AND ANALYTICAL REQUIREMENTS

Knowledge of operation and care of automotive equipment, including light trucks. The incumbent must have some knowledge of minor construction; repair and maintenance work; provisions of the California Vehicle Code applying to the operation of vehicles; highway maintenance procedures; highway or landscape maintenance and construction equipment and operation; servicing, minor adjustment, and emergency repair of such equipment.

Ability to read, write, and follow oral and written directions in English at a level required for successful job performance; do heavy manual labor; keep records. Assists in work relating to the maintenance of highway, structure and landscaped areas.

Skill in operating a variety of complex or heavy maintenance equipment, and making minor adjustments and emergency repairs to such equipment.

## RESPONSIBILITY FOR DECISIONS AND CONSEQUENCES OF ERROR

Poor decisions could result in the failure to properly service and maintain or operate equipment and cause excessive repair costs, loss of equipment and negatively impact work production. Negligence could also cause physical harm to the general public, operator and/or crewmembers. Employees of the State may be held liable for their own actions as a result of their carelessness on a job.

## PUBLIC AND INTERNAL CONTACTS

The incumbent may be asked to work with representatives from other public and private Local Agencies as well as all levels of Caltrans Management.

## PHYSICAL, MENTAL, AND EMOTIONAL REQUIREMENTS

Employee will be required to bend, stoop, climb, kneel, reach, push, pull and stand for long periods of time in various climatic conditions. May be required to assist in the clean up in the event of various types of accidents involving personal injury to others and/or hazardous spills. Must have ability to develop and maintain cooperative working relationships; respond appropriately to difficult situations; recognize emotionally charged issues or problems; and acknowledge the various responses. Employee must be able to work alone.

## SPECIAL PHYSICAL CHARACTERISTIC

Normal hearing and visual acuity of not less than 20/40 (with or without glasses).

## WORK ENVIRONMENT

The incumbent may/will be exposed to and work in loud noise, dust, chemicals, extreme weather conditions, great heights, confined spaces, uneven and unstable terrain, and next to vehicle traffic. The incumbent will be required to wear all personal protective equipment; move heavy objects; stand or sit for prolonged periods. Wear and use all required personal safety equipment. Follow all policies, and procedures. Will be required to work rotating or irregular shifts, including weekends, nights, holidays and overtime. Responds to after-hour emergencies.
