The Caltrans Audits and Investigations Office is sponsoring Two-Three scholarships\* ranging from \$500-\$1,000 for students who are majoring in or plans to pursue a career in accounting/auditing.

The scholarship is open to students at any accredited junior college or university in Sacramento County and its surrounding areas. The scholarship is competitive and based on the applicant's career path, communication skills, academic goals and need for financial assistance.

### SELECTION CRITERIA

- A student enrolled in 9 units or more who has either taken or is currently enrolled in Accounting 1A, Auditing, Finance, Statistics, or Business.
- An overall grade point average of 3.00 (attach official transcripts).
- Demonstrated need for financial assistance; e.g., have an application on file for financial assistance.

The selection process will consist of a review of the candidate's application, transcripts, written letters, and an interview with the most qualified candidates by a selection committee of the Caltrans Audits and Investigations staff.
