**STIP AMENDMENT 00S-009 ACTION**

**ACTION UPDATE FROM NOTICE**

This item was noticed at the February 2001 Commission meeting; the Commission requested the Action Item be placed on the consent calendar.

**SUMMARY**

This amendment programs \$1,647,000 from Los Angeles County's Unprogrammed Share Balance for an existing soundwall project on Route 91 in Los Angeles County replacing a like amount of Measure Funds erroneously identified as a source of funding. The total cost remains \$3,071,000.

**RECOMMENDATION**

The Los Angeles County Metropolitan Transportation Authority (LACMTA) is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines

**BACKGROUND**


This amendment programs \$1,647,000 from Los Angeles County's Unprogrammed Share Balance in FY 2000-01 for an existing soundwall project on Route 91 in Los Angeles County replacing a like amount of Measure Funds erroneously identified as a source of funding. The total cost remains \$3,071,000.

When this project was originally programmed in the 1998 STIP, it was shown jointly funded with both Regional Improvement Program (RIP) funding and Measure funding. It has now been determined that the Measure funding was shown in error. LACMTA wishes to maintain a fully funded project and is willing to commit funds from their unprogrammed share balance.
