BACKGROUND


This amendment programs \$90,000 for the design phase and \$450,000 for the construction phase for a total of \$540,000 in FY 2001-02 from San Mateo County's Unprogrammed Share Balance for the SamTrans North and South Bus Maintenance Facilities project in San Mateo County.

This project consists of design and re-paving work for the bus parking and fuel island areas as part of an ongoing rehabilitation of the SamTrans North and South bus maintenance facilities. This capital project is necessary to ensure optimal performance of maintenance and operational activities for the SamTrans bus fleet.
