SUMMARY

This amendment delays \$5,485,000 in Regional Improvement Program (RIP) funds from FY 2001-02 to FY 2003-04 for the construction components on an auxiliary lane project on Route 5 in San Diego County. There is no change in the total funding for the project.

BACKGROUND


This amendment delays \$5,485,000 in Regional Improvement Program (RIP) funds from FY 2001-02 to FY 2003-04 for the construction components on an auxiliary lane project on Route 5 in San Diego County.

During the preliminary environmental review phase, three endangered species were found in the area (California gnatcatchers, Pacific pocket mouse and the Light-footed clapper rail). It is estimated an additional 18 months are needed to complete the environmental review process to satisfy the requirements of the United States Fish and Wildlife Service and the California Department of Fish and Game. This will delay the construction components until fiscal year 2003-04.
