**STIP AMENDMENT 00S-030 – ACTION**

**ACTION UPDATE FROM NOTICE**

This item was noticed at the May 2001 Commission meeting; the Commission requested the Action Item be placed on the consent calendar.

**SUMMARY**

This amendment deletes \$13,450,000 of \$78,297,000 programmed in Grandfathered Regional Improvement Program (GF-RIP) funds from the Route 57/60 High Occupancy Vehicle (HOV) connector project in Los Angeles County and reverts it to the Los Angeles County’s Unprogrammed Share Balances.

**RECOMMENDATION**

The Department and the Los Angeles County Metropolitan Transportation Authority (LACMTA) are requesting this amendment.

**RESOLUTION**

Resolved, that the California Transportation Commission revise the 2000 State Transportation Improvement Program (STIP) at the end of the 30 day notice period.

## **BACKGROUND**


This amendment deletes \$13,450,000 of \$78,297,000 programmed in Grandfathered Regional Improvement Program (GF-RIP) funds from the Route 57/60 High Occupancy Vehicle (HOV) connector project in Los Angeles County and reverts it to the Los Angeles County's Unprogrammed Share Balances.

This amendment reduces GF-RIP funding programmed for the Right-of-way (R/W) component of the Route 57/60 High Occupancy Vehicle (HOV) Connector project from \$15,700,000 to \$2,250,000. In order to reduce the extent of environmental impacts to the existing wetland and a golf course in the vicinity of the project, the project is being redesigned to reduce the extent of right of way needed for the connector. This has resulted in cost savings to the R/W component of the project. The GF-RIP savings of \$13,450,000 in R/W capital costs will revert to the Los Angeles County's Unprogrammed County Share Balances. The impacts to the construction estimate cannot be determined until the design is more complete.
