DELEGATION OF ALLOCATION AUTHORITY
LOCAL ASSISTANCE ALLOCATIONS FOR RIDESHARE PROJECTS
RESOLUTION G-01-07 ALLOCATIONS

BACKGROUND

On February 22, 2001, the California Transportation Commission (Commission) delegated to the Department of Transportation (Department) authority to allocate funds by Resolution G-01-07 for Rideshare projects programmed in the State Transportation Improvement Program (STIP). In addition, the Commission delegated to the Department authority to advance the allocation by two years with the approval of the responsible regional agency. This authority allows the local agencies to begin work without waiting for the next CTC meeting to receive an allocation.

These Rideshare projects are included in the adopted STIP. The Department reports allocations on a monthly basis consistent with Resolution G-01-07.

SUMMARY

Pursuant to the authority granted by Resolution G-01-07, since the last report the Department made one allocation, totaling \$125,000 for one Rideshare project scheduled for implementation in Fiscal Year 00-01. Information about the allocation is attached.
