SUMMARY

BACKGROUND

This amendment programs \$685,000 from Placer County's Advance Project Development Element (APDE) for an interchange reconstruction project at Interstate 80 and Sierra College Boulevard. This project will complete the environmental and design phases for a project that will replace the overcrossing structure, widen the roadway, and reconstruct the interchange ramps.

The purpose of this project is to improve traffic conditions on Sierra College Boulevard at the I-80 interchange. Sierra College Boulevard is used as a regional corridor. This project will widen Sierra College Boulevard from two to four lanes and reconstruct the overcrossing to facilitate the future widening of I-80 and to improve vertical clearance. Construction is planned for FY 2003-04.
