BACKGROUND

This amendment adds \$55,000 in FY 2001-02 from Butte County's Unprogrammed Share Balance for the right of way component for a signalization project in the Town of Paradise.


The right of way component was originally programmed in the 2000 STIP for \$40,000, but lapsed in June 2001. No extension was requested and the funds lapsed because they had not been allocated in the year originally programmed. BCAG is now requesting \$55,000 be programmed for the R/W component for this project and will request the allocation of these funds concurrently with the action amendment.

BCAG is concurrently requesting a time extension for the construction component.
