STIP AMENDMENT 02S-006 NOTICE

SUMMARY

This amendment programs \$90,000 of Regional Improvement Program (RIP) funds in FYs 2002-03 and 2003-04 from Sierra County's Unprogrammed Share Balance for a project to replace an existing culvert with a bridge.

RECOMMENDATION

The Sierra County Local Transportation Commission is requesting this amendment. The Department of Transportation (Department) has reviewed the amendment and found it to be consistent with the California Transportation Commission (Commission) adopted State Transportation Improvement (STIP) guidelines. This project has not received State only funding approval. Commission staff has indicated that the only available STIP capacity is in FY 2006-07.

BACKGROUND


This amendment programs \$90,000 of Regional Improvement Program (RIP) funds in FYs 2002-03 and 2003-04 from Sierra County's Unprogrammed Share Balance for a project to replace an existing culvert with a bridge.

The box culvert at Howard Creek has exposed rebar at the center support and in the bottom slab, which reduces the structural capacity of the culvert. Replacing the culvert with a bridge will serve as the County's participation in a proposed Federal Highway project, which will result in higher hydraulic capacity, reduce the potential for blockage due to the center post, and eliminate blockage to fish passage. The Regional Improvement Program (RIP) funds will be used to match federal Highway Bridge Replacement and Rehabilitation (HBRR) funds.
