Ref: STIP AMENDMENT 02S-097

The Riverside County Transportation Commission (RCTC) and the Department of Transportation (Department) have requested that this proposed State Transportation Improvement Program (STIP) amendment be noticed at the June 2003 California Transportation Commission (Commission) meeting, and be considered for approval in August 2003. This notice is an informational item allowing the Commission to review the proposal, comment and/or ask questions prior to taking formal action in August 2003 or later.

RCTC and the Department propose to transfer \$8,550,000 of Interregional Improvement Program (IIP) funds from the Route 71 Widening project (PPNO 0048B) to the Route 91 Green River Drive Interchange project (PPNO 0076B) in FY 2004-05. This STIP Amendment will document the Riverside County Financial Allocation Adjustment (2.5g) approved by the Commission in May 2003.

RECOMMENDATION:

The Department recommends that the item be placed on the consent calendar for approval at the August 2003 Commission meeting.

BACKGROUND:

The Green River Drive Interchange project will replace an existing three-lane bridge with a six-lane bridge. This will accommodate future widening on Route 91 including auxiliary lanes linking Route 91 to Route 71.

A total of \$8,550,000 of IIP funds is needed to replace the anticipated loss of Traffic Congestion Relief Program (TCRP) funds and to fund a cost increase. The cost increase is due to new requirements for the National Pollution Discharge Elimination System (NPDES), complex staging of construction activities and accommodations for future improvements to Route 91.

RESOLUTION:

Resolved, that the California Transportation Commission (Commission) revise the 2002 State Transportation Improvement Program (STIP) at the end of the 30-day notice period as follows:


