ISSUE:

The attached resolution proposes to approve, for future consideration of funding, the following project for which a Negative Declaration has been completed:

- Construct onramp and off-ramp to complete an interchange in Simi Valley.

07-Ven-118, KP R51.5/52.3 (PM R32.0/32.5), PPNO 2972, State Route 118/Rocky Peak Road Eastbound Off-Ramp and Westbound On-ramp. This project is to construct two intersection ramps in Simi Valley. This project is fully programmed in the 2002 State Transportation Improvement Program (STIP) with \$2,265,000 of Regional Improvement Program (RIP) Funds. Construction is scheduled to begin in Fiscal Year 2003/04.

The Negative Declaration and supporting Initial Study have been transmitted to California Transportation Commission staff.

The Department of Transportation (Department) has approved the project for construction. This approval and the resulting filing of the Notice of Determination with the Office of Planning and Research will satisfy the environmental requirements for this stage of the project planning process.

RECOMMENDATION:

The Department recommends that the California Transportation Commission, as a responsible agency, approve the attached Resolution E-03-34.
