ISSUE:

The attached resolution proposes to approve, for future consideration of funding, the following project for which a Negative Declaration has been completed:

- Rehabilitate a culvert near Cummings.

The project is a State Highway Operation and Protection Program (SHOPP) Minor A Project scheduled for construction in FY 2003-04. The estimated total cost \$392,000.


The Negative Declaration and supporting Initial Study have been transmitted to California Transportation Commission staff.

RECOMMENDATION:


The Department recommends that the California Transportation Commission, as a responsible agency, approve the attached Resolution E-04-01.

Resolution E-04-01

- 1.1 **WHEREAS**, the California Department of Transportation (Department) has completed a Negative Declaration in compliance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines for the following project:
 - Route 101 in Mendocino County – Rehabilitate a culvert near Cummings.
- 1.2 **WHEREAS**, the Department has certified that the Negative Declaration has been completed in compliance with CEQA and the State CEQA Guidelines for its implementation; and
- 1.3 **WHEREAS**, the California Transportation Commission, as a responsible agency, has considered the information contained in the Negative Declaration; and
- 1.4 **WHEREAS**, the project will not have a significant effect on the environment.
