Ref: **STIP AMENDMENT 04S-022**

The City of Portola and Plumas County Transportation Commission (PCTC) are requesting the California Transportation Commission (Commission) approve this State Transportation Improvement Program (STIP) amendment. This amendment was noticed at the March 2005 Commission meeting.

PCTC proposes to transfer a total of \$474,000 of Regional Improvement Program (RIP) Transportation Enhancement (TE) Construction funds programmed under the TE Reserve (PPNO 3209) to a new Portola Pedestrian Improvement project (PPNO ~~2410~~ **3209A**) as follows: \$30,000 in FY 2005-06 for Design (PS&E) and \$444,000 in FY 2006-07 for Construction.

RECOMMENDATION

The Department of Transportation (Department) recommends approval.

BACKGROUND

In the 2004 STIP programming cycle, PCTC's Regional Transportation Improvement Program (RTIP) included \$744,000 of RIP funds programmed in a TE Reserve. The Commission, under Resolution G-04-07, approved the RTIP on August 5, 2004.

This amendment will transfer \$474,000 of RIP TE Construction funds programmed under the TE Reserve (PPNO 3209) to a new Portola Pedestrian Improvement project (PPNO ~~2410~~ **3209A**), located in the City of Portola, for \$30,000 in FY 2005-06 for PS&E and \$444,000 in FY 2006-07 for CON. The \$474,000 for the new Portola Pedestrian Improvement Project will come from the TE Reserves (PPNO 3209) as follow: \$137,000 from FY 2005-06, \$111,000 from FY 2006-07, \$171,000 from FY 2007-08, and \$55,000 from FY 2008-09.

RESOLUTION

Resolved, that the California Transportation Commission revise the 2004 State Transportation Improvement Program at the end of the 30-day notice period as follows:


