Subject: **STIP AMENDMENT 08S-020**

RECOMMENDATION:

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve 2008 State Transportation Improvement Program (STIP) Amendment 08S-020. This item was noticed at the Commission's April 15-16, 2009 meeting.

ISSUE:

The Santa Cruz County Regional Transportation Commission (SCCRTC) proposes to amend the 2008 State Transportation Improvement Program (STIP) for the Monterey Bay Sanctuary Scenic Trail Network project (PPNO 1872) in Santa Cruz County to move \$40,000 Regional Improvement Program (RIP) Transportation Enhancement (TE) Design (PS&E) programmed in Fiscal Year (FY) 2009-10 to FY 2010-11.

BACKGROUND:

The Monterey Bay Sanctuary Scenic Trail Network project (PPNO 1872) is programmed for \$40,000 of RIP TE for PS&E in FY 2009-10. SCCRTC would like to move this project to FY 2010-11 because additional time is needed for development of the Trail Network Master Plan prior to initiating PS&E of specific trail sections.

The funding plan has been updated to include an additional \$245,000 in Federal Demonstration funds that will allow SCCRTC to construct more trail segments.

RESOLUTION:

Be it resolved, that the California Transportation Commission does hereby amend the 2008 State Transportation Improvement Program for the Monterey Bay Sanctuary Scenic Trail Network project (PPNO 1872) to reflect the changes above and illustrated in the following table.
