Subject: **STIP AMENDMENT 08S-029**

RECOMMENDATION:

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve State Transportation Improvement Program Amendment 08S-029. This item was noticed at the Commission's May 14, 2009 meeting.

Action Update: Funding plans for Vallejo Paseo and Parking Structure – Segment 2 (PPNO 2260B) and Vallejo Paseo and Parking Structure – Segment 3 (PPNO 2260C) have been updated to show an exchange of \$1,716,000 Regional Improvement Program (RIP) with local funds between these two projects, as Segment 2 can be funded from the Public Transportation Account.

ISSUE:

The Solano Transportation Authority (STA) and the Department propose to amend the 2008 State Transportation Improvement Program (STIP) for the I-80/680/12 Interchange/Connector Phase 2 (PPNO 5301K), the Vallejo Ferry Terminal Intermodal Facility (PPNO 2260), and the I-80/680/12 Interchange (PPNO 5301L) projects as follows:

- Delete the I-80/680/12 “Connector” Phase 2 project (PPNO 5301K) from the STIP.
- Split the Vallejo “Ferry Terminal” Intermodal Facility project (PPNO 2260) into three segments, with the first two segments to be delivered in FY 2009-10 and the third in FY 2011-12.
- Add \$11,412,000 RIP FY 2011-12 funds to the I-80/680/12 “Interchange” project (PPNO 5301L).
- Update the project funding plans.

BACKGROUND:

The I-80/680/12 “Connector” Phase 2 project (PPNO 5301K) is a locally administered project programmed for construction with \$11,412,000 RIP in FY 2009-10, and includes local funds. The agency is ready to begin construction now using Regional Measure 2 funds. Therefore, the agency is requesting that the Connector project be deleted from the STIP, with the programmed amount returning to county shares.

The Vallejo Ferry Terminal Intermodal Facility project (PPNO 2260) is nearly a \$100 million planned improvement to be split into three two segments. Splitting the overall project will help advance the delivery of two of the three segments by two years. The first segment (the Vallejo Transit Center project [PPNO 2260A]) is to construct a two story 4,800 square foot administration building for the Vallejo Transportation Department, and is funded solely with local funds and is expected to be under construction this summer. The second segment (the Vallejo Paseo and Parking Structure project [PPNO 2260B]) is to construct a 750 stall, three-level parking structure along with a link to the Vallejo Ferry Terminal. Although the contract will be ready for award in FY 2009-10, the project is programmed in the STIP in FY 2011-12. The agency proposes to advance this segment to FY 2009-10 by using the STIP capacity made available from deleting the Connector project. The third and the final segment (the Vallejo Paseo and Parking Structure project [PPNO 2260C]) is to construct a 570 stall, three-level structure that will complete the parking structure portion of the overall project. The project is scheduled for construction in FY 2011-12 solely using local funds.

The overall I-80/680/12 Interchange project is currently in the environmental phase. Alternatives being considered include modifying existing interchanges, adding freeway lanes, and constructing new interchanges, auxiliary lanes, high-occupancy vehicle (HOV) lanes and frontage roads within and adjacent to the existing freeway rights of way. The overall project will be constructed in various phases. STA is proposing to program the next phase of the overall interchange project as the I-80/680/12 "Interchange" project (PPNO 5301L) and will partially reconstruct the I-80/Green Valley Road interchange. These improvements will include constructing the southbound (SB) portion of the ultimate Green Valley Road Overcrossing with an interim connection to the Lopes Road, and a 2-lane westbound (WB) I-80 to WB Route 12 Connector crossing the new WB I-80/Green Valley Road on-ramp. Construction will be funded using a combination of local funds, including Regional Measure 2, and \$11,412,000 RIP made available by deleting the Connector project. The Department will be the implementing agency for the construction phase of this contract.

As summarized below, these changes are revenue-neutral.
