Subject: **STIP AMENDMENT 10S-057**

## **SUMMARY:**

The California Department of Transportation will request that the California Transportation Commission (Commission) consider the requested State Transportation Improvement Program (STIP) amendment at the next scheduled Commission meeting following the notice period.

## **ISSUE:**

The Modoc County Transportation Commission (MCTC) proposes to amend the 2010 STIP to:

- Move \$207,000 from Fiscal Year (FY) 2012-13 to FY 2014-15 for the Modoc County TE Reserve (PPNO 2437).
- Shift \$50,000 of Regional Improvement Program (RIP) programmed in Design (PS&E) in FY 2013-14 to Right of Way (R/W) and combine with the \$157,000 of RIP R/W currently programmed for the Modoc Transportation Center project (PPNO 2449). It is also proposed to add an additional \$120,000 of RIP to R/W for a total of \$327,000 and program it in FY 2011-12.
- Change the implementing agency for the Modoc Transportation Center project (PPNO 2449) to the Modoc Transportation Agency.

## **BACKGROUND:**

This project was first programmed during the 2006 STIP Augmentation, with the intent to construct a new facility estimated to cost \$1,457,000 with construction to begin in FY 2011-12. With the limited funding available for the 2010 STIP, MCTC was only able to program \$50,000 in PS&E in FY 2013-14 and \$157,000 in R/W in FY 2014-15. Today, the economic downturn in Modoc County has led to lower property values, which have provided an opportunity to purchase an existing building rather than build a new facility. Suitable property in the downtown business district had been identified that would meet the need.

The changes proposed above are based on the approval of a separate concurrent STIP amendment for action, and reflected in the following tables.
