Subject: **FINANCIAL ALLOCATION FOR STATE-ADMINISTERED STIP PROJECTS ON THE STATE HIGHWAY SYSTEM RESOLUTION FP-06-29**

RECOMMENDATION:

The Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve the following resolution, allocating **\$56,274,000** for **two** State Transportation Improvement Program (STIP) projects on the State Highway System.

ISSUE:

The attached vote list describes **two** State-administered STIP projects on the State Highway System totaling **\$56,274,000**. The Department is ready to proceed with these projects and is requesting an allocation at this time.

FINANCIAL RESOLUTION:

Resolved, that **\$56,274,000** be allocated from Non-Budget Act Item 2660-801-3093 for **two** State-administered STIP projects, as described on the attached vote list.

The Department has complied with the National Environmental Policy Act and the California Environmental Quality Act requirements in preparing these projects.
